
With all the different messages surrounding the concept of sustainable investing, it is often hard for investors to understand its meaning and discover its benefits.

START WITH A SOUND INVESTMENT APPROACH

An effective investment solution must be based on sound investment principles.

At Stewart Group, we start with a broadly diversified, systematic investment strategy that emphasises securities with higher expected returns, as indicated by research, while also aiming to minimise unnecessary turnover and trading costs.

In our equity strategies, this means a greater focus on securities with smaller market capitalisations, lower relative prices, and higher profitability. In our fixed income strategies, we use information observed from yield curves to pursue higher expected returns across bonds of varying duration, credit quality, and currencies of issuance.

By starting with a time-tested, systematic investment approach, we can build diversified, cost-effective sustainability strategies that pursue higher expected returns while thoughtfully integrating the environmental criteria that matter most.



GUIDED BY ENVIRONMENTAL SCIENCE

We partner with global and domestic investment managers who work with leading climate scientists to understand current research, with an emphasis on the primary drivers of climate change—greenhouse gas (GHG) emissions and fossil fuel reserves that enable future emissions. Informed by a large body of research, our sustainability solutions are designed to address these and other variables.

REDUCED EMISSIONS EXPOSURE


Sustainability Trusts have achieved significant reductions in emissions exposure based on the collective emissions profiles of companies held in the Trusts.

The reductions are measured by both GHG emissions intensity exposure in tonnes of carbon dioxide equivalent (CO2e) per million of USD sales and potential emissions from reserves in megatonnes of CO2.

Understanding Reduced Emissions Exposure

As of 31 December 2020

A \$1 million (AUD) investment in the Global Sustainability Trust is exposed to 42.1 fewer tonnes of CO2e emissions per year than the same investment in the MSCI World ex Australia Index.*




SOME OF OUR ACTIONS (SO FAR)

Our office now runs on solar power. We aim to self-generate our own clean energy, reduce energy costs in the long term and enhance sustainability across our entire company.



We have strengthened our sustainable energy infrastructure by adding EV charging stations. Our fleet is now electric and will be run 100% on solar power.



By integrating our EV fleet with renewable on-site EVNEX charging stations we have simplified the transition to EVs and achieve an integrated system.



Park sharing platform Parkable provides flexibility and a seamless experience for staff, clients & the public to book parking spots with chargers supplying 100% clean energy for their EVs.





STEPPING UP OUR SOLAR

What started as a way to reduce our own reliance on the grid, has now grown into a community network of environmentally-focussed power users in Hawkes Bay, Taupō and Rotorua.

We have taken further steps from producing our own power and being a net exporter. We maxed out our solar panel placement with the help of Power Technology and Freenergy, and paired up with energy technology company Our Energy to create a first-of-our-kind collaborative, peer-to-peer electricity (P2P) solar network - all from little old Hastings, Hawkes Bay.

A TAONGA OF TE REHE GROUP

Te Rehe Solar Network has roots in Aotearoa's history, as well as an eye to our future.

The name "Te Rehe" pays homage to Nick's paternal fifth great-grandfather. Te Rehe was a Ngāi Tahu rangatira from the Ngāti Huirapa 'Arowhenua' hapū during the time of Te Tiriti o Waitangi. Te Rehe fought against the cunning Ngāti Toa chief Te Raparaha.

Our overall holding company, Te Rehe Group, holds many of our business taonga (treasures). We extended the concept to name Te Rehe Solar Network as well, as it is a reminder of our commitment to being kaitiakitanga (guardians, stewards) for our people, clients and community.


Kaitiakitanga
